

**Combined Graduate Level Examination, 2017-Declaration of revised result of Tier-I for appearing in Tier II and Tier III- reg.**

The result of Tier-I of CGLE, 2017 was declared on 30.10.2017 after considering representations of the candidates and finalization of Answer Keys. However, it was discovered that due to a technical glitch, a few tentative Answer Keys had not been revised. The Commission, therefore, undertook a comprehensive review. Based on the comprehensive review undertaken by the Commission, there has been a lowering in the cut off marks which has resulted in the revision of the result.

2. The revised result is as follows:

While processing the result, it was found that 15 candidates have appeared in the examination twice and 47 candidates who have been debarred by the Commission for unfair means have appeared in the examination. The result of these 62 candidates has not been processed. It is proposed to cancel the candidature of all the 62 candidates. 4. Pursuant to existing Court Orders, the results of 10 candidates with Roll Numbers - 2201026842, 2201045468, 2201062554, 2201098871, 2201105924, 2201272135, 2201293503, 2201325697, 2402006180, 2402019194 have not been declared.
5. Candidates belonging to reserved categories for whom certain percentage of vacancies are reserved, as per the policy of the Government must contact the respective Regional Offices of the Commission immediately if they do not belong to the category shown against their Roll numbers.
